Applications are currently being accepted for a Full Time multi-site Charge Medical Laboratory Technologist administratively attached to the Kincardine site of the South Bruce Grey Health Centre with shifts regularly assigned to the Walkerton site.

POSITION PURPOSE:

Reporting to the Manager, Laboratory Services, the Charge Medical Laboratory Technologist provides leadership and direction to all laboratory staff and is the subject matter expert on site for South Bruce Grey Health Centre. The Charge Technologist plans, organizes, and directs the day-to-day overall technical operations and specified administrative duties of the Laboratory through a team-oriented approach. The Charge Technologist is responsible for ensuring quality patient care through day-to-day planning and co-ordination of human resources including scheduling of staff and material resources; and uses clinical knowledge and leadership skills to promote the delivery of optimal care to all patients in a fiscally responsible manner; to provide leadership and technical expertise in the day-to-day operation of the site; to provide guidance and expertise in the evaluation of abnormal situations and results; the Charge Technologist must be knowledgeable and practice in accordance with the Medical Laboratory Technology Act, CMLTO, Accreditation Canada Diagnostics and Hospital regulations and standards. The Charge Technologist works within his/her scope of professional practice to process samples and perform medical laboratory tests, experiments and analyses to assist in the diagnosis, treatment and prevention of disease.

**** Note:** This position will be required to work weekends, shift and on-call assignments. Incumbents will be expected to provide coverage to all SBGHC sites as required.

Applicants must meet the following criteria:

- Six (6) years of combined recent clinical experience in a core lab setting and progressive leadership responsibility with clinical technical experience in the relevant medical laboratory, preferably in a hospital setting in the last 6 years
- Bachelor of Medical Laboratory Science Degree or College Certificate in Medical Laboratory Technology or BSc preferred
- Quality Management Certificate (or willing to obtain within 1 year from start date)
- Current registration with the College of Medical Laboratory Technologists of Ontario (CMLTO) required
- CSMLS Certification required
- Evidence of completion of recent leadership development training
- Demonstrated evidence of teaching and coaching skills and maintaining clinical competence through continuing education
- Demonstrated excellent oral and written communication and team building skills and diplomacy
- Relevant supervisory and/or project management experience in a hospital setting, preferred
- Advanced level knowledge in Chemistry, Hematology, and Transfusion Medicine
- Demonstrated knowledge of quality management, continuous improvement, quality control, quality assurance, financial management, and inventory control principles
- Demonstrated responsibility, accountability and decision making
- Working knowledge of lab and hospital software systems
- Ability to interact effectively with others within and outside of the organization (i.e. staff physicians, patients, suppliers, Ministry of Health, Pathologists, Occupational Health and Safety, CBS)
- Ability to maintain accurate records and documentation
- Experience with large and small analyzers, dedicated analyzers and microscopes
- Experience with Point of Care testing
- Ability to perform Phlebotomy and capillary collection
- Ability to function effectively and harmoniously in a team environment
- Ability to handle exposures to infection, noise, odours, working interruptions and high pressure situations
- Skills in leadership, problem solving, decision making and critical thinking

- Demonstrated knowledge and understanding of Accreditation Canada Diagnostics and regulatory requirements (e.g. CSA, OH&S, etc.).
